

#### WORKSHOP 1: Unpacking Unit 1, Area of Study 1 & 2

Carly Sparrow Korowa Anglican Girls' School, Glen Iris Ali Dunwoody Carey Baptist Grammar School, Kew

This workshop will adopt a comparative approach to examining the Key Knowledge of Unit 1, AoS 1 and 2. It will highlight new/altered content and identify content that remains unchanged from the previous Study Design. Suggestions regarding the depth required to meet the Learning Outcomes will be provided. Ideas for learning activities and resources to support the new content will also be presented. A sample timeline for covering AoS 1 and 2 as well as how and where to integrate Key Science Skills specified on pp. 12–13 of the new Study Design will be shared if time permits.

#### WORKSHOP 2: Unpacking Unit 1: Area of Study 3

#### Adina Wolters Mt Scopus College, Burwood

This workshop will provide an overview of Unit 1, AoS 3 by comparing and contrasting the requirements for this AoS in the previous Study Design with the new Study Design. Teaching and learning suggestions for the Key Knowledge as well as possible resources relevant to their delivery will also be provided. Suggestions about which Key Science Skills to cover for this AoS and learning activities to facilitate their development will be presented. Attention will also be given to the use of the student-adapted or student-designed scientific investigation and how best to approach the Learning Outcome for AoS 3 via this task.

#### WORKSHOP 3: Assessing Unit 1: Area of Study 1 & 2

Alisha Muller Haileybury College, Berwick Kate Gallagher Haileybury College, Brighton

This workshop will explore the assessment requirements for Unit 1 identifying assessment practices that have been retained from the previous Study Design and highlighting new practices and tasks specified in the new Study Design, including the Logbook requirement, and the 9 different assessment tasks prescribed on p. 27. This workshop will also provide suggestions as to where Key Science Skills could be integrated with Key Knowledge to best enable students to satisfactorily complete outcomes. Examples of summative assessment that can be used in the classroom will also be provided.

The panel will consist of Erin Wilson, VCAA and the presenters of all three Workshops. Questions can be typed into the Chat Box throughout all presentations. The questions received will be put to the presenters during this session and both the questions and the responses will be available for all participants to view and hear.
